Software License Agreement for Oranj Software Products

Please read this software license agreement (“License”) carefully before using this Oranj Software Product. By downloading, installing, copying, accessing or otherwise using this Oranj Software Product, you are agreeing to be bound by the terms of this License.

If you do not agree to the terms of this License, do not download, install, copy, access or use this software product.

Important Note: To the extent that this software may be used to produce user generated data files or material, it is licensed to you only for reproduction of non-copyrighted material, material in which you own the copyright, or material you are authorized or legally permitted to reproduce.

Any and all user generated material or data files produced by this Oranj Software Product are considered your property and you have full rights to your material under the full extent of the governing laws of the United States of America.

If you are uncertain about your right to copy or permit access to any material you should contact your legal advisor.

1. General.

A. The Oranj software and any third party software, documentation and any digital media accompanying this License are licensed, not sold, to you by Oranj Software, Inc. (“Oranj”) for use only under the terms of this License. Oranj retains ownership of the Oranj software itself and reserves all rights not expressly granted to you.

B. Oranj, at its discretion, may make available future upgrades or updates to the Oranj software for your compatible computer. 2. Permitted License Uses and Restrictions.

A. License. Subject to the terms and conditions of this License:
You are granted a limited, non-exclusive license to download, install, register (activate) and use one (1) copy of the Oranj software that you own or control per license.

B. Other Use Restrictions. You may make any number of copies of the downloaded Oranj software in machine-readable form for backup purposes only; provided that all backup copies must include all copyright or other proprietary notices contained on the original.

C. Trial License. You may register (activate) a trial license of the Oranj software product for evaluation purposes.
